Landowners were represented by R Levesque Associates. Mr. Karney presented the plan with 100 ft buffer, location of the silt fence at maximum extent of the lawn with hay bales, and erosion control material used on 3 to 1 slopes. Driveway and parking areas are in buffer zones so can be conditioned.

Mr. Barcomb moved to issue a Negative 3 with Southampton Standard Conditions for an RDA, Mr. Baker seconded. Motion passed with six (6) YES votes.
