# Whittemore Project Review – Eric Boudreau, Conservation Works LLC

Mr. Boudreau gave the SCC members an overview of his technical background including experience with the Easthampton Pomeroy Trail.

#### Trail Design

The redesign of the existing trails will address the risk and sustainability issues. The current location of stairs and paths is subject to erosion.

#### **NOI Data – Riverfront Area**

While on site doing the trail improvement/enhancement, technical wetland data will be gathered to be used in creating the NOI for a later project phase.

# **Survey Information**

Work to build a parking area off Meadow Lane would require the boundaries be accurately marked, but that would be in a subsequent project phase. The re-working of trails in the center of the property does not require a survey. Trail markers should be different in appearance than property line markers. The SCC could consider the design of the markers used on the Pomeroy Trail.

#### **Select Board Review**

The Southampton Select Board will need to approve and sign the contract with Conservation Works LLC. Mr. McDonald will address the BOS on October 7.

The SCC prioritized the work to be done at the Whittemore Conservation Area.

1)

- Remove steps, re-route trails
- Eliminate grade level stream crossing, build bridge
- Relocate trail to vernal pool out of wetlands
  - Vernal pool should be registered
- Relocate eroding stream-side trail up to hill side
- Perform general maintenance (protruding roots, steep dip)

- Plan Manhan River crossing, connection to Pomeroy
- Provide data for Notice of Intent

## **Pequot Road Complaint**

The abutters of 98 Pequot Road allowed Mr. McDonald access to their property to view and photograph the site in question. The site appeared to have been cleaned up.

8:39 A motion was made by Mr. Thibault to send a letter to the owner of 98 Pequot Road, copied to the abutters, about the activities permitted in and around intermittent streams. Mr. Lawrence seconded the motion. The motion passed unanimously with five (5) YES votes.

# 8:40 Tree removed near Red Brook

Mr. Kemp had been told that WMECO had removed the damaged tree which had been in close proximity to Red Brook, off of Gilbert Road. Utilities do not need to file for permits for routine maintenance.

#### 8:44 Part-time Conservation Agent: Easthampton Meeting & CIC Grant

A meeting between PVPC, Heather Budrewicz, the Mayor of Easthampton, the Easthampton Planners, Selectman Ed Cauley, and Mr. McDonald was held on September 29. Easthampton's Mayor, Karen L. Cadieux, agreed to pursuing hiring a joint Conservation Agent to work under 18 hours per week, with 60/40 split between Easthampton and Southampton. A Community Innovation Challenge (CIC) Grant is being sought to cover the Conservation Agent's first year's pay.

8 47 To accommodate Mr. Barcomb's work schedule, a motion was made by Mr. Kemp to change the meeting dates from November 3 & 17 to November 10 and from December 1 & 15 to December 8, 2014. Mr. Thibault seconded the motion. The motion passed with four (4) YES votes and one (1) NO vote (Ms. Hanc). Ms. Hanc stated that the November and December meeting dates had been published since the June 6 meeting minutes had been available.
