Chairman Ryan opened the meeting at 7:13pm with a roll call of Board members in attendance (Ryan, Royer, Bartlett, Jackson, Zukatynski, Robert, Soucy).

The Board discussed availability for meeting in December. The consensus of the Board was to keep with the regularly scheduled monthly meeting of December 9, however, with a start time of 5:30pm to accommodate Town Counsel.

The Capes of Berlin – substantial modification to a comprehensive permit
