# Town Hall Upper Level and Remote Access 1 South Main Street Friday, March 12, 2021 4:00 PM

Present: Selectboard members Nancy Allen, Henry Woolsey

Present in Person: Chip Bull, Thomas Gurganus – Petersham Broadband MLP Board

#### 1. 4:00 PM Call to order.

Chair Nancy Allen called the meeting to order at 4:00 PM at Town Hall upper level and via remote.

#### 2. New Business -

#### RE: Joint Meeting with Broadband MLP Board

The Selectboard met with the Broadband MLP Board to review and approve grant compliance documents for the Town-wide Broadband Project reimbursement submission to Massachusetts Broadband Institute (MBI) for the Town's designated \$880,000 MBI Broadband 123 Last Mile grant funding.

As of March 2021, Matrix had completed the project build-out with 99% coverage of the town. The MBI Agreement calls for 96% coverage. As of March 12, Matrix has 410 subscribers with the MLP Board noting that residents continue to sign up on a regular basis. Chip Bull briefly summarized that Matrix and their sub-contractor TriWire had begun their actual project construction in January 2020 after the Town's long wait for utility make-ready to be completed which it was in December 2019. The first Petersham customer was connected exactly one year ago in March 2020 and all of the work occurred during the extremely difficult year of the COVID-19 pandemic which had become a worldwide reality by February–March 2020.

Nancy Allen explained that the Treasurer was prepared to close out the project loan on April 2 rather than renew for another year. She noted that in conference with Michael Baldino of MBI on March 10 to review all grant compliance needs, MLP members had explained the overlap of Matrix finishing the project and the timing of the one year bank note and Mr. Baldino did not see a problem with expediting the reimbursement if all compliance documentation was in order so the Town would not need to renew the loan. The MLP Board was targeting Monday, March 15, for grant submission allowing two weeks for receipt of funds. It was noted that to that end, at their request, MBI had already been provided with the bank information needed for automatic fund transfer to Petersham.

The Boards reviewed individual Agreement compliance documents along with the MLP Board's Project Budget Summary and Utility Make-Ready Summary. Nancy noted that KPLaw was producing their compliance Certification for submission; Chip was communicating with Matrix for two compliance Certification documents

required by them; the Town Treasurer will be asked to join in signing the Financial Compliance document, and the MLP Board was working on the narrative Report which would be ready for March 15.

With review concluded, Henry Woolsey made a Motion for Nancy Allen to sign the Project Financial Compliance Certification for the Selectboard. Nancy seconded. Vote of approval was unanimous. The Certification will also be signed by Town Treasurer Dana Robinson.

With review concluded, Henry Woolsey made a Motion for the Selectboard and John Blum made the same, separate Motion for the Broadband MLP Board, that both Boards approve and jointly sign the required Project Compliance Certification and proceed to submit all documentation to MBI. The Motions were seconded by Nancy Allen and Andre Pierre for their respective Boards. Vote of approval was unanimous by both Boards. All documents were signed.

The meeting concluded with members noting once the reimbursement process is concluded, there would be a community celebration with all residents, Matrix and their contractors, MBI, and other State officials invited to join in to recognize project completion once the COVID-19 pandemic has subsided and large public gatherings are allowed.

#### 3. Next Meeting

The next Selectboard meeting date was confirmed for Tuesday, March 16, 2021, 6:00 PM.

#### 4. Adjournment.

There being no further business, Henry moved to adjourn at 4:30 PM. Seconded by Nancy. Motion passed unanimously.
