# Templeton Advisory Committee – November 18, 2021 @ 06:30 PM

#### MINUTES FROM THE BUSINESS MEETING

The Templeton Advisory Committee Pre-Town regular business meeting was being broadcast live on TCTV Channel 8 and the TCTV YouTube channel.

The Chairperson reserved the right to add items to, remove items from, or change the order of the agenda. However, the agenda is posted in advance to give the committee and public time to review the agenda items, and to ensure the meeting runs within the allotted timeframe.

# 1) Call to Order by Chairperson.

a. Mr. Rivard called the meeting to order at 6:30pm.

# 2) Pledge of Allegiance

# a. Veteran's Day Recognition

I. Mr. Rivard took a moment to recognize the passage of Veteran's Day, which was last week on Thursday, 11/11/2021.

### 3) Review & Approval of Meeting Minutes

### a. October 28, 2021

- Mr. Spring moved to approve the minutes of October 28, 2021 as presented. Mr. Caplis seconds.
- II. **Discussion:** Mr. Graves, recognized by the Mr. Rivard, suggested several amendments. *Mr. Spring and Mr. Caplis agreed to amend their motion as such.*
- III. **Vote:** After discussion, the motion on the floor was to approve the meeting minutes of October 28, 2021, <u>as amended</u>. <u>Motion carries</u> **6-0-0 at 6:34pm.**

### 4) Public Comments

a. Theresa Griffis, as a resident, gave a formal invitation to the Advisory Committee to come to the Tree Lighting Ceremony on December 5, 2021.

b. Jeffrey Bennett, as a resident, spoke to the resignation of Mr. Rivard from the Advisory Committee, and thanked him for his service; all in the room agreed with Mr. Bennett's comments.

# 5) Correspondence

- a. **November 11, 2021 –** Resignation, Matthew Rivard.
  - Ms. Bartolomeo moved to enter into the record as read and reviewed and note it takes effect on November 26, 2021, at 5:00pm. Mr. Caplis seconds.
  - II. **Discussion:** Mr. Spring expressed regret and sorrow at Mr. Rivard's resignation and spoke to his leadership on the Committee during his term as Chair. The Committee agreed with Mr. Spring's sentiment.
  - III. **Vote:** After discussion, the motion on the floor was to enter the document into the record as read and reviewed and note it takes effect on November 26, 2021, at 5:00pm. <u>Motion carries 6-0-0 at</u> 6:39pm.
- b. **November 14, 2021 –** From Kelli Pontbriand, adjustment to certified free cash.
  - Mr. Caplis moved to enter into the record as read and reviewed.
     Mr. Spring seconds.
  - II. Discussion: Ms. Pontbriand explained the series of events that led to this error on the original certification of the certified free cash. She expressed her condolences for the mistake.
  - III. **Vote:** After discussion, the motion on the floor was to enter the document into the record as read and reviewed. **Motion carries 6-0-0 at 6:41pm.**
- c. **November 09, 2021 –** From Adam Lamontagne, DRAFT proposed usage of free cash, prepared BEFORE the item in 5C.
  - I. Mr. Rivard moved to recommend the Town Administrator revise his proposed usage of free cash to align with the Town Accountant's recertified numbers. Ms. Bartolomeo seconds.
  - II. **Discussion:** Mr. Lamontagne spoke to the need to change the numbers within the proposed usage of free cash. Mr. Caplis asked about the changes that would made to the planned Stabilization Accounts as a result, and Mr. Lamontagne stated such changes.
  - III. **Vote:** After discussion, the motion on the floor was to recommend the Town Administrator revise his proposed usage of free cash to align with the Town Accountant's recertified numbers. <u>Motion carries 6-0-0 at 6:44pm.</u>
- d. **November 15, 2021** From Michael Currie, an invitation to an All-Boards Meeting on December 6 @ 6:30 PM at the Senior Community Center.
  - Mr. Spring moved to enter into the record as read and reviewed.
     Mr. Caplis seconds. <u>Motion carries 6-0-0 at 6:45pm.</u>

- e. **November 15, 2021 –** From Kelli Pontbriand, the October 2021 Budget vs. Actual (BvA) Document.
  - I. Ms. Bartolomeo moved to table review of the October 2021 BvA to the December 2, 2021, meeting. Ms. Honsa seconds. Motion carries 6-0-0 at 6:46pm.

# 6) Old Business

- a. From September: Advisory Committee Policy General Stabilization Fund Policy
  - I. Mr. Spring moved to approve as presented and forward to the Administrative Intern for posting to the Town website. Ms. Bartolomeo seconds.
  - II. **Discussion:** Mr. Caplis asked if the Town already has a Stabilization Fund Policy. Mr. Spring clarified it was just a policy by the Committee itself, not a Town-wide policy. Mr. Rivard clarified the edits would be removed before submission. Mr. Bennett spoke to clarify that some of the numbers mentioned with the policy were incorrect for Fiscal Year 2022. There was an exchange between Mr. Spring and Mr. Bennett regarding the validity of the values presented for Fiscal Year 2022. Mr. Spring spoke further that the numbers listed were. Mr. Rivard suggested to make an amendment to state it is the FY22 budget from the May Annual Town Meeting, and not as amended. *Mr. Spring and Ms. Bartolomeo amended their motion as such.*
  - III. **Vote:** After discussion, the motion on the floor was to approve as presented and forward to the Administrative Intern for posting to the Town website as amended. **Motion carries 6-0-0 at 6:53pm.**
- b. **Comparison Communities:** Discussion tabled from previous meeting. Wilfred Spring presents communities he has researched that could be part of the final document.
  - I. Mr. Spring gave information regarding his choices within the document he provided to the Committee. Mr. Spring asked Mr. Caplis for his experience on what the Select Board is looking for in their Comparison Communities. Mr. Caplis stated he was impressed by Mr. Spring's work and spoke to his experience in this topic as a former Select Board member and how the additional data points that Mr. Spring looked seem appropriate and beneficial.
  - II. Mr. Spring moved to send a letter to the Select Board asking if there are any specific criteria they would like the Advisory Committee to use in preparing the Community Comparisons, and to send a copy of Mr. Spring's document as guidance. Mr. Caplis seconds. Motion carries 6-0-0 at 7:01pm.

- III. Mr. Spring spoke to the levy limit and its constraints as a clarification for residents watching this meeting.
- IV. Mr. Spring moved to table the discussion Community Comparisons until the regular business meeting on January 20, 2022. Ms. Bartolomeo seconds.
- V. **Discussion:** Ms. Bartolomeo spoke to the value of the work Mr. Spring did.
- VI. **Vote:** After discussion, the motion on the floor was to table the discussion Community Comparisons until the regular business meeting on January 20, 2022. **Motion carries 6-0-0 at 7:05pm.**

# 7) New Business

- a. **October 13, 2021:** From Adam Lamontagne, a request regarding a project for which ARPA funds may be used.
  - 1. Ms. Bartolomeo moved to recommend the Select Board approve the suggested use of ARPA funds for a study by the Town Auditors on revenue replacement. Ms. Honsa seconds.
  - II. Mr. Caplis left the meeting at 7:06pm.
  - III. **Discussion:** Mr. Lamontagne spoke to this request. Ms. Pontbriand spoke to this item as well. Mr. Spring asked why Mr. Lamontagne was asking the Committee why he wanted their input; he believes it is more under the jurisdiction of the Select Board. Ms. Bartolomeo spoke to how the ARPA funds are of benefit to the Town, and how concerns about the future of the Town. Ms. Bartolomeo spoke to a time in 1991 the State of Massachusetts did not provide any aid to the Town, and the struggles the Town went through during that time. Mr. Rivard praised the Town Administrator for seeking the Advisory Committee's input on the matter.
  - IV. **Vote:** After discussion, the motion on the floor was to recommend the Select Board approve the suggested use of ARPA funds for a study by the Town Auditors on revenue replacement. <u>Motion carries</u> **5-0-0** with one absent at 7:13pm.
- b. October 22, 2021: From Kelli Pontbriand (Town Accountant) FY 2022 Q1
   General Accounts Activity Report & Special Articles Activity Report.
  - I. Mr. Caplis returned to the meeting at 7:14pm.
  - Mr. Spring moved to enter into the record as read and reviewed.Mr. Caplis seconds.
  - III. Discussion: Ms. Pontbriand spoke to this item. Mr. Spring spoke to the difficulties of forecasting revenue loss for the end of the year.Ms. Pontbriand spoke to how this is requested quarterly by the Select Board. Mr. Lamontagne spoke to progress on the Special

- Articles and the progress on procurement of various projects the Town voted to do.
- IV. **Vote:** After discussion, the motion on the floor was moved to enter the document into the record as read and reviewed. <u>Motion carries</u> **6-0-0 at 7:18pm.**
- c. **October 12, 2021:** From Wilfred Spring Proposed Templeton Advisory Committee Orientation Document.
  - I. Mr. Spring moved to approve the document as presented and post to the Town website as an Advisory Committee guidance document. Ms. Bartolomeo seconds.
  - II. **Discussion:** Mr. Spring spoke to how he saw several communities have something like this, and so he wrote this as to help new members understand what the Advisory Committee does. Ms. Bartolomeo agreed with Mr. Spring's work.

- e. Appointment to the Narragansett Regional Agreement Amendment Committee (RAAC) to replace Matthew Rivard, effective November 26, 2021, at 5:00 PM (Chair moved this agenda item until during Agenda Item 10, before Mr. Rivard's Committee Comments):
