- ~ RESOURCE CONSULTANTS conduct Intake Interviews by phone, Monday Friday, from 9:00 am 5:00 pm LifePath's Phone Number is 413-775-5555
- ~ The consultants will listen to the caller's questions/concerns and direct them to appropriate services. There are no Income Restrictions for these services.
- ~ Most callers are just looking for specific information about resources in their area. People in our town are often referred to Petersham Partners.
- ~ The Aging in Place Network includes:

Meals on Wheels Senior Luncheons in a Community Facility Health & Wellness Classes

Home Care Information

One-time and ongoing assistance (Transportation to appointments, shopping, small household repairs, check-in services, etc.)

Lynn noted that LifePath's biggest issue is finding enough people to provide Home Care services. They also have difficulty in "Branding" - letting people know that LifePath is a strong advocate for them, and can provide information about the whole range of services available.
